**It is agreed, Castlerock Kennels requires all puppies to be named with the prefix "Castlerock.", not doing so forfeits the entire guarantee outlined below.**

No guarantee is made at time of sale regarding show, hunting, or breeding prospects of sold dog.

This dog is guaranteed to be in good health, to the best of my knowledge at the time of this sale, and has had initial inoculations against distemper, hepatitis, para/parvo virus and received worming. The buyer has **(3) three days** from day of purchase in which to have the dog checked by a licensed veterinarian, and is urged to do so. If the veterinarian finds the dog to be seriously ill which is presently seriously affecting the quality of life of this pup, the cause of which is clearly hereditary in nature (this guarantee does not cover the presence of parasites, protozoa, urinary infection or kennel cough, as these are commonly found in pups); return the dog to Castlerock Kennels along with the AKC Registration papers. Another pup of similar breeding and color will be given in exchange. Money refund will be given only if no other pups are available at that time, provided a letter from the examining veterinarian is offered as proof of serious and severe life altering illness. It is agreed and understood that any exchange must be made within the three-day guarantee period. The seller assumes no responsibility for this dog after leaving premises for medical expense, mortality, landlord's disapproval, allergic reaction to dog, disagreement with family, behavioral/training difficulties, mistreatment of dog, accidental poisoning or trauma to dog, regrowth of dewclaws or for any other reason not listed above.

This dog is also guaranteed to **one year** of age against severe, life-threatening congenital heart, liver, kidney, or thyroid defects, cancer, or seizure disorder. In addition, this puppy is guaranteed, until one year of age, against **severe crippling hip dysplasia**. This pup is guaranteed against any genetic eye condition leading to complete blindness in the first year of life. Should any of these defects occur, which are clearly hereditary in nature and seriously affect the dog's quality of life, return the AKC Registration papers and a letter from **two** licensed veterinarians confirming the defect(s) and a spay/neuter verification from your vet; all required paperwork as outlined in this contract **MUST** be received by Castlerock Kennels within 2 months of diagnosis (this includes spay/neuter, vet requirements confirming defect and original registration papers; if not received in this time frame, this entire guarantee is null and void and no replacement puppy shall be given. When the above requirements are received by Castlerock Kennels, a puppy will then be offered as a replacement of equal value (breeder's choice) when next litter of comparative value is available. In the case of hip dysplasia, you must also submit copies of radiographs (x-rays) taken by two veterinarians which are specific and conclusive proof of severe hip dysplasia. Also, **a statement from your two veterinarians** that this puppy is not and never has been overweight for its bone structure, and no evidence that this puppy was overstressed, or over exercised during this important growth phase. This is limited to a one-time replacement and no further guarantees are made. It is agreed and understood no money refund will be given.

If a replacement pup is given, it is the sole responsibility of the buyer for the return shipping to the breeder and the shipping costs for the replacement pup. No discounts will be given.

In the event of litigation regarding this dog or contract; it is agreed all litigation will occur in the county of Franklin, North Carolina.

It is further understood and agreed that no warranty or representation has been made with respect to sold dog, except as set forth in writing in this agreement. This guarantee is valid only for original owner and is non-transferable. I (we), the purchaser(s), have read, understand and agree to the contents of this contract.
